



DePaul Breathes New Life into Old School

Built in 1896, Public School 60 has had a presence in the Buffalo, New York community for over 100 years, serving as the educational foundation for the Black Rock neighborhood until recently. Closed for ten years, the school will soon have a new lease on life. DePaul has begun converting the site into a mixed-use campus to include a total of 68 affordable housing units.

"This school will once again be a centerpiece of city living," Vice President of DePaul Properties, Inc. Gillian Conde said.

Representatives from the city of Buffalo, DePaul, SWBR Architects, R&P Oak Hill Development, New York State Housing and Community Renewal (NYHCR), state and local government officials, and members of Rediscover Riverside and the Black



Rock Riverside Alliance celebrated the groundbreaking of the Riverside Apartments on November 14 at 238 Ontario Street.

"This will be an economic catalyst for this area," said Buffalo Mayor Byron Brown. "These apartments will support area businesses, strengthen the fabric of community in Riverside and be a springboard for new investment."

The \$20 million project will be funded by a combination of \$1.5 million in city HOME funds, along with state and private funding. Over 350 construction jobs will be created, and later 40 permanent jobs will be added to the community. The Riverside Apartments are scheduled for completion in January 2014.



Carriage Factory News

Progress is being made on the Carriage Factory Apartments in Rochester, New York. Built in the 1900s for the production of horse-drawn carriages, the former Cunningham Carriage Factory is being converted into a mixed-use campus that will include 71 affordable housing units.

The \$22 million Carriage Factory project was highlighted by U.S. Senator from New York Charles Schumer during a press conference in early December. Senator Schumer was advocating for an extension of the Historic Tax Credit, which could be used in DePaul's redevelopment of the Cunningham Carriage Factory, located in Rochester's historic Susan B. Anthony neighborhood.

SWBR Architects is designing the Carriage Factory Apartments and Christa Construction is serving as the general contractor.

Remembering Connie Miller, an advocate for those with mental illness

Constance Miller, a former DePaul Community Services board member, passed away on September 9, 2012 at the age of 93. Mrs. Miller was a lifelong advocate for those with mental illness.

The Corfu native graduated from William Smith College in Geneva with a bachelor's degree in sociology and a master's degree in social work from the State University of New York at Buffalo. She worked at the Buffalo Psychiatric Center, eventually becoming unit chief. She also helped found the Genesee County Mental Health Association.

In addition to her work with DePaul, Mrs. Miller served on



the Rochester Board of Visitors to the Rochester Psychiatric Center, the Community Services Board of Genesee County and Living Opportunities of Western New York. She was named Volunteer of the Year by the New York State Mental Health Association in 1995 and received the Lifetime Achievement Award from the New York State Commission of Mental Health in 2002.



Bread Time Stories at Woodcrest Commons

Mix yeast, flour and water with memories, pour them into a pan and bake. 4 a.m. before she went to work to bake bread, while another resident shared his fond memories of making challah bread with his grandmother on Saturdays, said Woodcrest Activities Director Lindsay Lown. Fery left residents over 30 loaves of his homemade Country White Bread.
