DePaul Breaks Ground on Joseph L. Allen Apartments in Schenectady

DePaul joined with county, state, public private partners on May 5 to celebrate the groundbreaking of the Joseph L. Allen Apartments, which represents a \$17.9 investment million at 780 Albany Street Schenectady's Hamilton neighborhood.

DePaul constructing a new

three-story, 52,500 square foot building that will feature 51 new studio, one- and two-bedroom apartments for income-eligible tenants. The apartments will fill a critical need for new housing in the neighborhood, which lacks quality affordable apartments and housing, and will also serve those with behavioral health needs. Onsite supportive case management will be available through the Schenectady Community Action Program (SCAP) linking tenants to needed services in the community including housing assistance, employment services, daily and community living skills training, healthcare monitoring, linkages and referrals to community services, and support groups. The Joseph L. Allen Apartments are named in honor of Schenectady's first African American City Councilman, a beloved and revered community member.

The development plans incorporate "green" standards, including using Energy Star rated appliances and lighting fixtures; low or no VOC paints, primers, adhesives and sealants; green label plus carpeting; high-efficiency furnaces and condensing units for heating and cooling. In addition, the Joseph L. Allen Apartments will be certified to Version 3.1 of the Energy Star Certified for Homes program, Enterprise Green Communities Criteria Program 2015, and the NYSERDA Low Rise Residential New Construction program. Construction is expected to be complete in the summer of 2017.

"DePaul is very excited to be a community partner in meeting the



tremendous need for quality affordable housing supportive options in Schenectady and throughout New York State," said DePaul President Mark H. Fuller. "We wish to thank Governor Cuomo, the State and our partners for providing DePaul with the funding that has made this project a reality. We

are so proud to be part of the transformation and revitalization of the Hamilton Hill neighborhood community. The DePaul Joseph L. Allen Apartments are an example of progress and partnership in action." Continued on Page 2

"This new development will make a tangible difference for people here in Hamilton Hill, a neighborhood with an undeniable need for fresh investment, new jobs and quality affordable housing," said New York State Homes and Community Renewal Commissioner James Rubin. "Far too many New Yorkers spend more than a third of their income on keeping a roof over their heads. That's why Governor Cuomo's housing programs are designed to expand housing opportunity and choice for people in communities across the state. More than that, we are making it possible for people to live independently while getting the support they need. This can make the difference between having a home of one's own and becoming homeless."

"Under Governor Cuomo's leadership, the Office of Mental Health has created over 6,000 units of supportive housing across the state in the last five years and we are proud to have yet another opportunity to provide affordable, supportive housing for individuals with behavioral health needs," said New York State Office of Mental Health Commissioner Dr. Ann Marie T. Sullivan. "Supportive housing is one of the most effective pathways to help New Yorkers achieve independence and the Joseph L. Allen Apartments will provide tenants with much-needed resources and community linkages."

The Governor's Office of Storm Recovery Executive Director Lisa Bova-Hiatt said, "Schenectady's rental housing supply was severely affected by Hurricane Irene and a key element of the Joseph L. Allen Apartments is its location outside the local flood plain. Our objective is to build back better and with greater resiliency. While we cannot control nature, we are able to minimize its destructive impact."

"The Joseph L. Allen Apartments is a prime example of what can be achieved when various government agencies truly combine their energy and expertise to enhance the quality of life of fellow New Yorkers with special needs," said Senator Hugh Farley. "An added benefit will be the boost to the local economy which this construction activity will bring."

Assemblyman Angelo Santabarbara said, "Over the last

decade, we've seen the ongoing transformation of Downtown Schenectady into a vibrant upstate destination. The investments are now being extended to our city's neighborhoods with projects like the new Joseph L. Allen Apartments, which will add strength and vitality to our city. This is a project about people; people in public service partnering with the private sector to make significant investments in our neighborhoods that are helping local families and residents find a safe place to live with the support services that make a difference. The completion of this project will mark another important step in building stronger, vibrant communities in our great city of Schenectady."

"This is a positive development on several levels," said Assemblyman Phil Steck. "The Joseph L. Allen Apartments is a fitting honor to a dedicated public official where our fellow New Yorkers will have a supportive, modern, and energy-efficient place to call home in Hamilton Hill."

John B. Rhodes, President and CEO, New York State Energy Research and Development Authority (NYSERDA) said, "Governor Cuomo's Reforming the Energy Vision to achieve a cleaner, more affordable, and resilient energy system builds energy goals into state-funded affordable housing projects like the Joseph L. Allen Apartments. Residents and managers will benefit from these energy-efficient apartments for years to come, in the form of lower energy bills, improved indoor air quality and lower maintenance costs."

Mayor Gary McCarthy said, "Working closely with DePaul and our economic development team, we were able to secure this \$17.9 million investment in Hamilton Hill. We celebrate the start of construction for Joseph L. Allen Apartments and we look forward to additional investments in the Albany Street corridor in the months ahead."

"We thank DePaul Properties for working together with the County's economic development team to line up the site for this new \$17.9 million investment," said Anthony Jasenski, Chair of the Schenectady County Legislature. "It is great to see construction now underway for a development that will certainly act as a catalyst to bring additional investment and jobs to support our neighborhood revitalization efforts in Schenectady County."

Schenectady City Councilwoman Marion Porterfield said, "Governor Cuomo's commitment to expanding affordable housing

\$10 billion investment in the House NY 2020 program to create or preserve 100,000 affordable units over the next five years. The development is also receiving funding through the Governor's Office of Storm Recovery (GOSR) as a result of damage caused by Hurricane Irene. The \$10 billion House NY 2020 plan boosts state spending on housing programs by nearly \$5 billion and will create and preserve 100,000 affordable housing units across the state, along with supporting services for New Yorkers seeking affordable housing.

New York State financing for the development was provided by HCR Low Income Housing Tax Credits and NYSOMH loans and grants, a grant from NYSERDA, and a Community Development Block Grant Disaster Recovery loan from GOSR. The City of Schenectady has abated real estate taxes through a Payment in Lieu of Taxes (PILOT) program and JP Morgan Chase provided the Letter of Credit.

NYSAFAH Conference Features DePaul StoryCorps Profile

StoryCorps, an independent nonprofit project whose mission is to honor and celebrate the lives of everyday Americans by listening to their stories, recorded and edited the story of DePaul's Mike Cook as interviewed by DePaul Properties Director of Operations Melissa O'Geen. The story was produced on behalf of the New York State Association for Affordable Housing (NYSAFAH) and was selected as the only story presented and featured at the NYSAFAH conference in May. Cook's story is being retained by StoryCorps for possible future use on their program. It is also archived in the Library of Congress in Washington, D.C., as part of an initiative to preserve and make available for use experiences of those who are African American.

Mike is a cook at Halstead Square, a DePaul Single Room Occupancy Program in Rochester, New York, and an affordable housing resident of the DePaul Neighborhood of the Arts Apartments (NOTA). Cook's colleagues at Halstead Square guided him toward



applying for a three-bedroom apartment for income-eligible tenants at the NOTA Apartments where he has lived since March of 2013.

"I can't tell you how much these people mean to me," he said of his family of co-workers at Halstead Square. "I have a stable job and a great place to live. It's changed the quality of life for me and my kids."

NCADD-RA Tackles Problem Gambling

It is estimated that more than five million Americans are affected by a gambling addiction, but as this disorder too often goes unrecognized, only eight percent of those with this addiction ever seek treatment.

The National Council on Alcoholism and Drug Dependence-Rochester Area (NCADD-RA) is partnering with the New York Council on Problem Gambling for the fifth consecutive year on the 2016 YOU(th) Decide outreach project.

Project goals include:

- Increasing awareness of the issue of underage gambling and the importance of decreasing youth access to gambling among parents of school-aged youth and community leaders.
- Increasing awareness of key media literacy facts.
- Increasing youth awareness of the common misperceptions of gambling.
- Increasing parental action toward the issue of underage gambling.

During this project, which runs through October 30, NCADD-RA will be offering, upon request, youth problem gambling media literacy training. The NCADD-RA is also seeking youth who are interested in becoming involved in advocacy activities in their school or community. Care Management at DePaul

DePaul's Care Management program in Rochester and Buffalo, New York is designed to provide an extra layer of support for DePaul Single Room Occupancy (SRO) Program and some Treatment Apartment Program (TAP) residents with mental health needs, particularly those who are experiencing frequent emergency room visits or hospitalizations. Care managers work with clients to identify problem areas and create a plan to improve their overall health. They partner with residential staff and the client's current providers in order to streamline care and support residents in following through on recommendations for care.

Individuals with a serious and persistent mental illness who are currently receiving Medicaid are eligible. They must be able to identify goals and may not already be enrolled in a similar program through another organization. Clients may be referred to Care Management by residential staff.

According to DePaul Vice President Chris Syracuse, DePaul is currently serving about 100 clients in Rochester and 80 in Buffalo with numbers anticipated to grow.

"Care management augments what staff at our other sites do to help keep clients stable and in their place of residence," said Syracuse. Community Partnerships Forged through DePaul Hopelink Programs

DePaul Hopelink at Shelter Cove and DePaul Hopelink at East Ridge are short-stay residences for adults being discharged from a medical hospital.

DePaul Hopelink at Shelter Cove serves people who are currently hospitalized at UR Medicine/Strong Memorial Hospital for health-related issues and no longer require the acute services provided by the hospital. DePaul Hopelink at East Ridge serves adults who are currently hospitalized at one of Rochester Regional Health's hospitals for health-related issues and no longer require the acute services provided by the hospital. The programs serve as therapeutic, short-term solutions for individuals who cannot return to their place of residence upon discharge from the hospital. Individuals who lack a permanent residence are also eligible for these programs.

Individuals placed at DePaul Hopelink at Shelter Cove are eligible to receive services and therapies, if indicated, from home care nurses and aides through UR Medicine Home Care Services. DePaul staff will provide meals, coordination and transportation to appointments, housekeeping services, laundry, and linkages to more permanent placement and entitlements. The residence is staffed 24 hours per day, seven days per week by DePaul housing specialists. Nursing services are provided by UR Medicine Home Care Services and will depend on the individual's needs and what is prescribed by the physician.

Individuals placed at DePaul Hopelink at East Ridge are eligible



to receive services and therapies, if indicated, from home care nurses and aides through Rochester Regional Health. DePaul staff will provide meals, coordination and transportation to appointments, housekeeping services, laundry, and linkages to more permanent placement and entitlements. The residence is staffed 24 hours per day, seven days per week by DePaul's housing specialists. Nursing services are provided by Rochester Regional Health and will depend on the individual's needs and what is prescribed by the physician.

The overall goal is to provide individuals with the support they need, enabling either a return to their residence or securing a residence that is appropriate for their long-term needs.

INQUIRING MINDS
