Reserves within the **2011-12 Budget**

The establishment and funding of reserves is an important consideration in the maintenance of a sound financial plan for any school district. While strict adherence to state law is required to ensure reserves are both legal and appropriate, adequately funded reserves are vital to the long-term health and stability of the school district. This concept is recognized by the New York State Comptroller:

Saving for future projects, acquisitions, and other allowable purposes is an important planning consideration for local governments and school districts. Reserve funds provide a mechanism for legally saving money to finance all or part of future infrastructure, equipment, and other requirements. Reserve funds can also provide a degree of financial stability by reducing reliance on indebtedness to finance capital projects and acquisitions. In uncertain economic times, reserve funds can also provide officials with a welcomed budgetary option that can help mitigate the need to cut services or to raise taxes. In good times, money not needed for current purposes can often be set aside in reserves for future use. (Office of the New York State Comptroller — Local Government Management Guide — Reserve Funds, Pg. 1)

The Kendall Central School District believes that the judicious use of reserves greatly reduces long term borrowing costs, smoothes large fluctuations in tax rates and minimizes the possibility of draconian mid-year budget cuts which would have a direct impact on students. It believes it is in the best interest of both the students and taxpayers to prudently establish and use reserves to weather the financial storms and uncertainties that will occur. Again, the Comptroller notes:

The practice of planning ahead and systematically saving for capital acquisitions and other contingencies is considered prudent management. Saving for future capital needs can reduce or eliminate interest and other costs associated with debt issuances. Similarly, certain reserve funds can be utilized to help protect the budget against known risks (a potential lawsuit) or unknown risks (a major ice storm). (Office of the New York State Comptroller — Local Government Management Guide — Reserve Funds, Pg. 2)

A Letter from the Elementary Principal

Dear community members,

With the coming of the nice weather, our students like to wear spring/summer footwear to school. Students need to continue to wear proper footwear to Physical Education (PE) so that your child and their classmates can move safely during class.

- Appropriate footwear includes sneakers that tie or Velcro across the tongue of the shoe and that have a regular sneaker sole to provide proper support for your child's feet and ankles.
- Please make sure your child's sneakers fit them so that they do not walk out of their sneakers.
- Sometimes Velcro wears out on sneakers. Please periodically check your child's sneakers. When the Velcro no longer stays attached, the sneakers fall off easily. This is dangerous for your child and his/her classmates.
- We encourage you to practice tying shoes with your child if they are still learning. We understand that some laces are difficult to tie tightly because of the materials they are made of, but some students' fingers are not strong enough to tie the laces tightly. Practice will help this.
- We are constantly reminding all students to tie their shoes before we start the activities in PE. We will continue this practice and will encourage students to stop and position themselves near one of the PE teachers when they re-tie their sneakers. This will help with safety for all. We are always willing to help students tie their shoes and the students are aware of this.
- SHOES NOT APPROPRIATE FOR PE slip on shoes, boat shoes, crocs, dress shoes, girls' shoes that look like sneakers but do not have a sneaker sole, sneakers with eyes for the laces without laces and sandals.
- At no time are flip flops or "Heelies" allowed in school. This is for safety in the gym, on the playground, in the classroom, etc.

Dear community members,

A reminder for all parents that the school day at the junior/senior high school ends at 2:35 p.m. and practice for sports teams does not begin until 3:20 p.m. This schedule allows students to receive extra help from their teachers. The school does provide a sports study hall for students who remain at school until practices begin. However, many students chose to leave the school grounds between 2:35 and 3:20 to have a snack, change for a game, or prepare for practice. The school does not monitor students' whereabouts unless they are attending one of the school study halls or receiving help from a teacher. Please make sure you clearly articulate your expectations to your child regarding what they are allowed to do before practice begins. Many students walk to the nearby convenience store or hang out with other students outside before practice.

We are entering the last month of our 2010-2011 school year and it could be argued that it is the most important month of the year for our students. Our students will be taking their Regents and/or local exams, which accounts for 20% of their final averages. Students must past five Regents exams to earn a Regents Diploma including English, Global Studies, US History, Algebra, and a Science Regents. Please help us prepare your children

for these importance examinations. Encourage your child to attend the review sessions after school. The extra practice and review will certainly help students master the information and prepare for their examinations. The Regents review sessions for each course are posted on the Kendall School website.

I have attached the June 2011 Regents schedule for your reference. Your children have worked hard all year and we want to ensure they finish the year by attending reviews and completing their homework. Finals will be administered on June 13th and 14th. We have extended periods scheduled for these two days and your child will take different exams both days. It is imperative your child does not miss these two days of school. Please make sure your child is well rested and eats a healthy breakfast. Please contact your child's teachers or me if you have any questions or concerns.

If you do not live within the District and pay school taxes to another school district, that is where your children must legally attend school. If you moved from the Kendall District from another school district, you must register and have your children attend the school district where you pay school taxes.

If it is found that you live in another district and have falsely attended Kendall Schools, you will be charged tuition for the time your child has attended school in the
