



Trolley Station Apartments

DePaul joined with city, state, public and private partners to celebrate the opening of the DePaul Trolley Station Apartments at an open house and presentation on September 15 for the 48-unit community in Canandaigua, New York serving income-eligible tenants. The new apartments fill a critical need for affordable housing, and also offer on-site supports to accommodate tenants with behavioral health needs, providing linkages to services in the community.

"The Trolley Station Apartments will provide some of our most vulnerable New Yorkers in the Finger Lakes a chance to live a life of dignity and independence," said Governor Cuomo. "The completion of this project brings us one step closer to ensuring that every New Yorker has the opportunity to have a safe, decent and affordable place to call home."

The new, two-story 49,000 square foot building represents an almost \$15 million investment in the town of Canandaigua. The New York State Office of Mental Health provided a \$150,000 Program Development grant, approximately \$2.5 million in interest-free construction financing, and over \$300,000 in funding to support annual service and operation expenses. Additional support was provided by New York State Homes and Community Renewal with \$441,657 in Low Income Housing Tax Credits.

The affordable housing project also received \$6.5 million in tax-exempt bond financing from the New York State Housing Finance

Agency, with an additional \$3.25 million Medicaid Redesign Team subsidy, a \$152,200 incentive from NYSERDA for compliance of standards with the Energy Star Certified Homes Program, and a \$4.2 million equity investment from First Sterling.

The DePaul Trolley Station Apartments were made possible through collaboration among partners including Christa Construction, DePaul, First Sterling Financial, Inc., JPMorgan Chase Bank, N.A., Ontario County Department of Mental Health, New York State Homes and Community Renewal, New York State Office of Mental Health, State of New York Mortgage Agency, SWBR Architects and the Town of Canandaigua.

"DePaul is pleased to be a community partner in meeting the need for quality affordable housing options in Canandaigua

and throughout New York State," said DePaul President Mark H. Fuller. "We wish to thank Governor Cuomo and the State for providing DePaul with the funding that has made this project a reality. We are so proud to be part of the Canandaigua community. The DePaul Trolley Station Apartments are an example of progress and partnership in action."

Each one- and two-bedroom apartment features a fully-equipped kitchen with a range, refrigerator and microwave, and a wall-mounted flat screen TV including basic cable service. Heat,

hot water and electric are included in the rent and community laundry facilities are available on each floor at no cost. There is also individually-controlled heat and air conditioning as well as off-street parking. The entire building is Wi-Fi accessible. There is a secure storage area for each tenant, in addition to a lounge on each floor and a community room. The building is 100 percent smoke free. On-site housing specialists are available to provide optional case management. Applicants must meet the eligibility requirements set forth by the Low Income Housing Tax Credit Program. Income and occupancy requirements apply.

The development incorporates “green” standards, including using Energy Star rated appliances and lighting fixtures; low or no VOC paints, primers, adhesives and sealants; green label plus carpeting and high-efficiency furnaces and condensing units for heating and cooling. In addition, the Trolley Station Apartments are certified to Version 3.0 (Rev. 07) of the Energy Star for Homes program and the NYSERDA Low Rise Residential New Construction program standards for additional long-term energy savings to the project. The project also includes photovoltaic solar panels that will decrease the demand for grid-based electrical usage for Trolley Station.

To offset the cost of panel installation, New York State Energy Research and Development Authority provided \$33,350 in funding through the NY-Sun program. The project also received \$119,946 in New York State Solar Tax Credits. The solar panels are expected to save more than \$16,000 annually by providing the housing development with 58 percent of its overall electricity consumption.

“It is a pleasure to see Trolley Station Apartments join tens of thousands of other homes and buildings in New York State that have added solar energy through Governor Cuomo’s NY-Sun initiative,” said New York State Energy Research and Development Authority President and CEO John B. Rhodes. “Solar energy protects the environment and creates jobs while supporting Governor Cuomo’s Reforming the Energy Vision, a strategy to build an energy system that is clean, resilient and affordable for all New Yorkers.”

“Trolley Station is a welcome addition to the wide array of services the Office of Mental Health supports in the Finger Lakes,” said New York State Office of Mental Health Commissioner Dr. Ann Sullivan. “Housing does make a difference. A secure environment with easily accessible behavioral health services can help put

individuals on the road to recovery while allowing them to remain involved in the communities they love.”

“Affordable, supportive housing helps people succeed independently in their communities. Trolley Station joins other developments like Veterans for Canandaigua and Cadence Square that illustrate Governor Cuomo’s commitment to meeting a need for quality homes and services in the area, and HCR is happy to celebrate this new housing asset in the Finger Lakes,” said New York State Homes and Community Renewal Commissioner James S. Rubin.

“On behalf of the Canandaigua Town Board, it is a pleasure and an honor to welcome the Trolley

Station Apartments to our community,” said Town of Canandaigua Supervisor Pamela Helming. “DePaul has done a tremendous job building quality, affordable, and community-focused apartments. As the Town of Canandaigua continues to grow, these apartments will undoubtedly be in high demand from people seeking a place to call home.”

“Safe, affordable housing options are limited across the county,” said Diane Johnston, Director, Ontario County Office of Mental Health. “We welcome DePaul and their additional housing opportunities for individuals in our community. The development has both one-and two bedroom units for those meeting income requirements. For individuals with behavioral health concerns, additional supports to assist in coordination with local service providers will be available. We are pleased to partner with DePaul and welcome the agency to Ontario County.”

Looking Back on Trolley Travel

As it pulls into the station, the sunlight glints off trolley car No. 157. A rich olive green adorned with gold lettering numbers and striping, and varnished mahogany-framed opal glass panes, the car appears in all its glory in a composite image created by photographer Janet Cruz and graphic artist Benson Pearson which serves as one of the pieces of art at DePaul's Trolley Station Apartments, a 48-unit community in Canandaigua, New York which opened in September.

"The name Trolley Station pays homage to the site's former use as a stop on a trolley line designed to transport employees to a large orphanage built in Canandaigua after the Civil War. The orphanage served children who were displaced or orphaned after the war," said Vice President of DePaul Properties Inc. Gillian Conde, "but the addition of the image of the trolley that actually rode on the line in Canandaigua adds a deep, local historical connection to the Trolley Station community."

"To bring the trolley outside again, placing it at an actual

stop original to the area, makes it an exciting piece which is important for both DePaul and the New York Transportation Museum which has painstakingly restored the trolley and recognizes its importance to our area's history," she said. Janet and Benson have done an outstanding job on so many levels combining powerful images and using computer artistry to capture this important story."

Conde said the historic imagery of car No. 157 adds a powerful statement to a beautiful building.

"Our design partner SWBR does an outstanding job creating interior space that is physically bright and attractive that also flows and supports tenants, guests and community," said Conde. "We provide needed, beautiful, quality housing to be proud of while recognizing the local community of which we are a part. We believe it brings depth to our building to incorporate local history into our designs."

Responding to the Rise in Heroin and Prescription Pain Medications

In response to the ongoing rise in heroin abuse and prescription pain medication misuse as well as rising numbers of overdoses in our community, DePaul's National Council on Alcoholism and Drug Dependence-Rochester Area (NCADD-RA) brought together individuals from multiple sectors to create the Monroe County Opioid Task Force. During bimonthly meetings, local and state data have been reviewed, assets and barriers specific to the opioid epidemic have been identified, and a mission and set of goals have been established.

There have been several successes that include the passage of the NYS Comprehensive Opioid Legislation package and the federal passage of the Comprehensive Addiction and Recovery Act. The Monroe County Opioid Task Force seeks a comprehensive multi-sector response with approaches that include prevention education, treatment, recovery, and enforcement strategies. The goals include access to services equal to that of other diseases, immediate access to treatment as well as after-care and wrap-around services, access to Narcan to reverse opioid overdoses, access to prevention education services, clear processes for low-level crime referrals to treatment, and access to medications to support treatment and recovery.

Progress is underway and resources have been created that include the "Treatment Availability Dashboard" found at the New York State Office of Alcoholism and Substance Abuse Services (OASAS) website at www.oasas.ny.gov; a series of NYS OASAS YouTube videos (Navigating the Substance Use Disorder System of Care Series) found at www.oasas.ny.gov/treatment; and the resource-rich Combat Heroin website at www.combatheroin.ny.gov.

The Monroe County Opioid Task Force continues to move forward to ensure that individuals and families impacted by the disease of addiction will have full and complete access to services equal to that of other diseases. The task force seeks to remove the stigma surrounding the disease of addiction. Prevention education efforts, with requests to NCADD-RA for education on opioids, are at an all-time high. NOTA's Julia W. Comes Full Circle

On August 31, Julia W. of DePaul's Neighborhood of the Arts (NOTA) Apartment Treatment Program, cracked the books on a new chapter in life as a part-time graduate student in a Masters of Public Health program at the University of Rochester.

It's a dream that the 35-year-old Webster, New York native has put on hold for many years as she learned to manage and live successfully with depression.

"It wasn't really a surprise because hindsight is 20/20," Julia said of her diagnosis. "It had been percolating for a long time."

Diagnosed in 2000 at the age of 19 during her junior year of college, Julia graduated with her bachelor's degree in nursing from the State University of New York at Brockport in 2004. Following graduation, she worked in the pediatric intensive care unit at Strong Memorial Hospital, in medical oncology at Rochester General Hospital and in quality assurance and management in Planned Parenthood.

The final blow came in 2007 when she was served a foreclosure notice on her house. After a suicide attempt, Julia said she wound up at home with her parents where she spun her wheels for a few years, seeking support from a day program. After a second suicide attempt in 2011, she began to formulate a plan to move out on her own. She moved to NOTA in 2012.

"Everything happens for a reason, so although that was a terrible experience and I wouldn't want to do it again, it got me here," she said of DePaul's NOTA apartments. "DePaul is awesome in that it has given me the tools with which to put my life back together."

With her diagnosis under control, Julia has begun pursuing the goal of returning to college for her master's degree. She started with online courses and then applied to the University of Rochester's Masters of Public Health program in the spring.

She received her acceptance letter on May 11, "the day that shall live in infamy" as she refers to it.

"It was one of the greatest moments of my life right there," she said of being one of 12 students accepted into the program.

Residential Counselor Meagan Licata said Julia inspires her every day and she considers herself very fortunate to work with her.

"Julia has worked to fight her demons every day with tenacity and determination, and despite how much effort that takes every day, she has accomplished goals that are lofty for people without those obstacles," said Licata. "Her dedication to her craft and her passions have been instrumental in her recovery."

Julia said she hasn't felt suicidal in five years thanks to



her stable housing, support network and medication.

"The medicines don't make you better. They don't make you happy," she said. "It gives you a stable platform to build on. It's up to me to do the hard work. Learning to sit with those uncomfortable feelings is part of what you have to do. It's life."

Julia also finds solace in singing with the Rochester Oratorio Society and the Rochester Women's Community Chorus. A soprano, Julia sings a wide variety of music, including pop, Broadway, and more traditional works, but classical music remains

her favorite. She's been studying voice with Allyn VanDusen for two years now.

While she's struggled with self-esteem, Julia says, singing gives her confidence. She is excited to become a student again, and also nervous because of the work load and student loans.

"There's always the fear of what if I can't do it, but I'm not going to find out unless I try, and I think I can," she said. "One thing I've learned over the years is life is not linear. We go around in circles. We go back and forth, but eventually we will get ahead I hope!"

Smiling Faces and Sticky Fingers

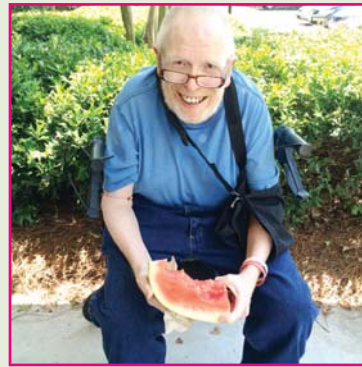
