

Soaring into the 21st Century with New Technology

New technology in the Kendall School District is helping students soar into the 21st century. The District began adding technology three years ago with interactive white boards, and now, it is being used in grades K-12 every day to engage and prepare students for college and careers.

Districts are required by law to have a technology plan, and to update it every three years, according to High School Principal Carol D'Agostino. Kendall's policy can be found on the District web site. The District's Technology Committee has a process in place for determining how the current technology is being used, and which technology should be added in the future.

"We need to be fiscally responsible when we're making the decisions about what technology really should come into the District and where it's going to have the biggest impact on our students," said D'Agostino.

The new technology will require changes to the District's Code of Conduct to allow students access to technology throughout the day. Tools such as e-book readers, iPads, and laptops are currently banned from school buildings.

"We're hearing from students that they need those technology tools to take notes and learn," said D'Agostino. "That jump to college

is a significant change in their lives, so we're trying to remove any barriers so we can set them up for success."

Shari Hardenbrook, Kendall's Monroe 2-Orleans BOCES Instructional Technology Specialist is available to support staff in their technology needs, and a user group including elementary and high school teachers allows staff to collaborate on best practices and increase their "tool kit" of tips and tricks.

High School Science teacher Kristin Flint said the white boards and document cameras have allowed her to expand her curriculum with Internet and videos that reinforce the classroom materials.

Technology teacher Jeff Decker uses an interactive white board to illustrate technical drawing, to allow students to manipulate 3-D models and computer simulations, and to encourage sharing of work and collaboration among students. Decker is also

using the school broadcast system in conjunction with new technology in a television studio at the High School to create a student-run morning announcement show.

New technology is also making it easier for parents to track their child's academic progress, attendance and more through Parent Portal. There are currently 966 Parent Portal accounts, and of the 827 students enrolled in the District, 676 students have at least one parent with a parent portal account. What you always wanted to know about a Board of Education...

What is a board of education?

The board of education (BOE) in a school district is similar to what a board of directors is in a business. The primary functions of the board are to develop the broader, longer range goals and plans (called policies) which determine the basic framework for the educational programs, services and facilities to be offered to the youth of the community. NYS laws and regulations place the responsibility for carrying out educational mandates with a board of education. Even though elected locally, a school board is technically an official state body.

What are the requirements to be a KCS board member?

To be a member of the Kendall BOE, you must:

- a. be at least 18 years old
- b. be a United States citizen
- c. live in the KCS District

How do you get on the ballot to run for the Kendall BOE?

To be placed on the voting machine ballot, you must submit a petition signed by 25 or more qualified KCS voters to the district clerk at least 30 days before the May vote, which usually means before the middle of April. These petitions are available in the District Office or by calling 659-2741.

How many members are on the KCS board?

The Kendall BOE consists of five members.

How long do board members serve at KCS?

Each board member is elected to a five-year term.

How many terms can a member serve?

The number of five-year terms a member wishes to serve is an individual choice, except that a person must run and win re-election for each five-year term.

How many vacancies on the board are there each year?

With five members each serving a five-year term, only one board position is up for election each year.

What is the salary for a KCS board member?

There is no salary paid to board members, but they are reimbursed for expenses incurred while on board business, such as mileage, conference registration, and so forth.

When, where, and how often does the KCS board of education meet?

Usually the BOE meets once a month in the Jr. /Sr. High School Library. These meetings start at 7 p.m. and last two to three hours. Occasionally, special meetings are called to focus on special topics, such as budgeting, evaluating the superintendent, construction projects, and so forth.

How do new board members become familiar with how a board operates?

Prior to becoming a board member, any person who wishes may attend a board meeting. After being elected, the board president and the superintendent will meet with the new board member to help orient him/her, to provide relevant materials, and to answer questions. In July and September, the NYS School Boards Association provides a two-day orientation session for new school board members. Additional experience is gained by participation in actual board meetings and workshops.

Do board members have to spend a lot of extra time on KCS committees?

There are many school related organizations outside of KCS, such as the New York State School Boards Association, the Orleans School Boards Association, and the Western New York Education Service Council, which hold meetings and seminars for interested school officials. However, individual KCS board members may participate only if they wish to. The individual board member's own interests and preferences determine extra time in these organizations.

Board of Education Petitions

Any person interested in running for the vacancy on the KCS board of education must submit the proper petition on or before Monday, April 18, 2011. Petitions are available upon request in the District Office or by calling 659-2741. The petition must be signed by at least 25 qualified voters of the KCS District and may be filed with the district clerk in the District Office between 8 a.m. and 4 p.m. on any business day through Monday, April 18, 2011. The incumbent is Patrick Donahue.

Volunteers Needed

Volunteers are needed to donate three hours to help with the Annual Budget Vote and Board Member Election Tuesday, May 17, 2011, from 6 a.m. to 9 p.m. at the Elementary School. Did you know the tax levy (the amount collected by the District in property taxes) has been below 1.62 percent since 2008-09 and was zero for the 2009-10 school year?

Did you know the tax rate (percent paid by property owner per thousand) was a negative -6.68 percent in 2008-09, a negative -2.61 percent in 2009-10 and .91 percent in 2010-11?

Did you know the budget to budget (roll over of budget from one year to the next) has been below 4 percent since 2008-09 and was .84 percent last school year? This low percent reflects solid financial planning given the double digit increase in health insurance premiums, and the rise in pension, fuel and food costs.

A Letter from the Jr. /Sr. High School Principal

We are quickly approaching the spring and summer months and students will begin to wear their spring and summer attire to school. Please remind your children about what clothing is appropriate for school. The Code of Conduct, section 5312.10, outlines the following guidelines:

- Individual students and parents/guardians have the responsibility for student dress and general appearance. Students are required to attend school in appropriate dress that meets health and safety standards and does not interfere with their education or the education of others as determined by the Building Administrator. Students may be asked to wear appropriate protective gear in certain classes such as physical education, wellness, and technology.
- Students must wear appropriate clothing. In accordance with administrative expectations, the wearing of hats, bandanas, and other forms of headwear is prohibited during the regular school hours. Overcoats, shoes with rollers, or clothing worn inappropriately (unbuttoned to the point of immodesty, too tight, see-through, etc.) are all examples of unacceptable dress. Students are not allowed to display bandanas or other gang affiliated items.
- A student's dress should not reveal any skin between the upper chest and mid-thigh. A student's dress shall ensure no undergarments are exposed. A student's dress shall include footwear (not slippers) at all times and footwear that is a safety hazard will not be allowed. Students cannot wear pajamas or slippers to school. A student's dress, grooming, and appearance, including hair style/color, jewelry, make-up and nails, shall not promote and/or endorse the use of alcohol, tobacco, or illegal drugs and/or encourage other illegal or violent activities.

- Clothing and attire which have an expression (phrase, word or words) or insignia (picture, symbol, patch or pin) which is obscene or libelous (that is, which contains objectionable language, including insults, whether directed to themselves or others), or which advocates racial or religious prejudice is forbidden.
- Students who violate the student dress code shall be required to modify their appearance by covering or removing the offending item and, if necessary or practical, replacing it with an acceptable item. Any student who refuses to do so shall be subject to discipline, up to and including In School Suspension (ISS) for the day."




